Course description, purpose of the course:

The course introduces students to the history of international organizations, their general characteristics, structural features and decision-making procedures. General theoretical knowledge is supplemented by detailed information on selected past and present international organizations, including the League of Nations, the United Nations and the North Atlantic Treaty Organization. Course requirements include the presentation of a selected universal or regional international organization in class.

Presentations should be based on individual research and should include, as appropriate, the historical background of the selected organization, the process of establishment, the original and present scope of membership, the conditions of membership, the principal organizational units, the functions and powers of organizational units, the decision-making procedures of organizational units, and a short personal assessment of the activities of the organization. The list of selectable international organizations will be distributed in class; organizations not included in the list may be selected with permission only.
