

Rector's Order No. 9/2022 (III.7)/R on the amendment and revocation of certain emergency measures

Pursuant to Article 43 (3) of Act CCIV of 2011 on National Higher Education and Article 32 (1) of the Organizational and Operational Rules of Károli Gáspár University of the Reformed Church in Hungary I hereby issue the following order:

- 1 § Point 3.8 of Rector's Order No. 9/2021 (VIII.27)/R on the Operation of Residence Halls, Colleges for Advanced Studies and Rented Accommodation of Károli Gáspár University of the Reformed Church in Hungary for the academic year 2021/2022 with regard to the control of the coronavirus pandemic (hereinunder referred to as Rector's Order No. 9/2021 (VIII.27)/R) shall be replaced by the following provision:
- "3.8 It is not obligatory to wear a facemask indoors, however, anyone is entitled to wear it, and no one should be prohibited for wearing a facemask."
- **2** § Points 2.2, 3.3 to 3.7 and 3.23 of Rector's Order No. 9/2021 (VIII.27)/R shall be repealed.
- 3 § Point 2.5 of Rector's Order No. 11/2021 (IX.03)/R on the organization and implementation of the Academic Year 2021/2022 during the period of state of danger (hereinunder referred to as Rector's Order No. 11/2021 (IX.03)/R) shall be replaced by the following provision.
- "2.5 It is not compulsory to wear a surgical or safety mask or a mask made of textiles or other materials in the buildings of the University, however, anyone is entitled to wear it, and no one should be prohibited for wearing a facemask."
- **4** § In point 2.6 of Rector's Order No. 11/2021 (IX.03)/R, the words "Chancellor's Office" shall be replaced by the words "Directorate General for Economic Affairs".
- **5** § Point 3.3.1 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "3.3.1 Larger groups and crowds are to be avoided in the communities and in the buildings of the University. Facemasks shall be worn in accordance with point 2.5."
- 6 § The last sentence of point 3.3.4 of Rector's Order No. 11/2021 (IX.03)/R shall be repealed.
- 7 § Point 3.4.4 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "3.4.4 In the 2nd (spring) semester of the academic year 2021/2022, from 16 March 2022 until withdrawal, the University will switch to face-to-face teaching in the correspondence work schedule. Accordingly, lectures, seminars, practical classes will be held primarily by physical attendance."
- **8** § Point 3.5.1 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "3.5.1 The establishment of the student status takes place through the process of enrolment, which should be done primarily in small groups, personally or by a proxy, during which, after entering the university buildings, the wearing of facemasks, the use of hand disinfectants and keeping a safe distance is mandatory. Facemasks shall be worn in accordance with point 2.5."



- **9** § Point 4.1 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "4.1 During the internships, the general hygienic rules shall apply to the students and teachers participating in the internship, practical trainings. Before the start of the practical training, hand washing with soap or alcoholic hand disinfection is mandatory. During the practice, the maintenance of adequate safety distance and the use of a facemask shall be applied as specified in point 2.5 and in accordance with the requirements of the practical training place."
- 10 § Point 5.5 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "5.5 During the oral and written examinations with the personal presence of the students it is compulsory to keep a safe distance and to comply with the provisions of point 2.5. Between the examinations the work surfaces and aids should be regularly disinfected."
- 11 § Point 6.1 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "6.1 Rules on security measures applicable to events shall apply to holding university events. If possible, an online connection should be ensured to the conferences and events organised by the university."
- 12 § Point 9.1 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "9.1 When planning to travel abroad in the framework of official trips, teaching, staff or student mobility, university employees and persons employed by the University in other employment relationship are obliged to comply with the:
 - 9.1.1. recommendations of the Consular Service,
 - 9.1.2. entry rules in force in the country of destination and transit,
 - 9.1.3. travel conditions of the travel agency,
 - 9.1.4. rules of the authorities of the host country,

in accordance with the University's rules on the organisation of official trips in Hungary and abroad, and student mobility."

- 13 \ Point 10.1 of Rector's Order No. 11/2021 (IX.03)/R shall be replaced by the following provision:
- "10.1 The libraries and other organisational units of the University where the reception of clients (i.e. students, lecturers) is involved should operate in the opening hours published on their websites, in compliance with the general epidemiological regulations and the mask wearing provisions of point 2.5. For these organisational units the dean of the responsible faculty may introduce additional regulations, if necessary."
- 14. § The following points and annexes of Rector's Order No. 11/2021 (IX.03)/R shall be repealed:
- a) Points 3.4.5 to 3.4.6,
- b) Points 3.7.4 to 3.7.5, and 3.7.7,
- c) Points 6.2 to 6.8,
- d) Points 9.2 to 9.4

15 \S Rector's Order No. 8/2022 (II.14)/R on the holding of events not related to teaching, research and scientific work shall be repealed.

16 § This Order shall enter into force on 7 March 2022.
